## MONTHLY DUES

Your WSHA Board of Directors are giving constant special attention to the small percentage of our homeowners who do not pay their monthly dues. By failing to pay your monthly dues, you add to the burden that makes the treasurer's job an already difficult volunteer duty even more difficult. Please get your dues in, on or before the 1st of the month.

## POOL GUIDELINES

The WSHA Board feels it needs to re-affirm some of the past and current guidelines for using the pool.

- The buoy rope in the center of the pool needs to remain in place at ALL times. This is a safety issue as it defines the end of the shallow end and the beginning of the deep end of the pool. **Please DON'T put pressure on the rope nor unhook it.**
- Wash pool toys with Clorox and water.
- Wash swimwear after going from other bodies of water—rivers, lakes, and ocean—and entering our neighborhood pool to avoid starting algae.
- Eating in the pool area is NOT allowed per county guidelines. Please eat in the area behind the clubhouse. Food has been eaten in the pool area recently and caused ant infestation in the baskets.
- Alcohol is prohibited in the pool area.
- Shower before getting into the pool.
- **CLOSE** the bathroom door after use.

Not adhering to the rules and guidelines mentioned can lead to deactivation of your E-Card, per item 4 of your E-Card receipt form that you signed.

## **E-CARD REPLACEMENT**

To replace a lost or misplaced E-Card it will cost \$25. To meet one's demand for a replacement quickly, a temporary code will be provided which will be good for 5 days and then it will become deactivated. This will give the homeowner time to find their card and coordinate with Stu Nosky in obtaining a replacement E-Card.
